



Rambo Investigations — Pay List & Retainer Breakdown

Billing increments: 0.25 hr (15 minutes) • **Time zone:** ET

No minimum surveillance hours. All work requires a signed agreement and retainer (unless flat fee arrangement has been made).

Hourly Rates

- Scheduled (24 hours notice) Daytime Surveillance (6:00 a.m. – 9:00 p.m., any day): \$100/hr
- Scheduled (24 hours notice) Night Surveillance (9:00 p.m. – 6:00 a.m., any day): \$125/hr
- Unscheduled (within 24 hours) Daytime Surveillance: \$150/hr
- Unscheduled (within 24 hours) Night Surveillance: \$175/hr
- OSINT / Desktop Research (as needed): \$100/hr
- Report Writing / Exhibit Prep: \$100/hr
- Court/Deposition/Testimony (portal-to-portal): \$100/hr

Mileage, Travel & Expenses

- Mileage: \$0.70/mile (door-to-door).
- Parking / Venue Entry: Actual cost (receipts provided)
- Long-Distance Travel (>60 miles one way): Travel time billed at ½ the applicable hourly rate
- Holiday Rate (major U.S. holidays): +50% on hourly

GPS Device Rates

- \$250 installation fee + \$20 daily fee

Covert Camera Rates

- \$250 installation fee + \$20 daily fee



Retainers (Applied Against Time & Expenses)

- Standard Cases (domestic/civil): \$1,500
- Multi-Day / Two-Investigator or Business Matters: \$2,500–\$5,000 (scope-based)
- Corporate/Insurance Programs: \$5,000

How retainers work: We bill actual time/expenses against the retainer. When the balance falls below \$500, work may pause pending replenishment. Any unused retainer is refundable within 10 business days after final invoice.

Payments accepted: ACH, debit/credit, business check. (Card: +3% processing.)

Cancellation / Reschedule

- <2 hours' notice: 2 hours billed per scheduled investigator (covers prep/drive-out)
- Weather/venue shutdowns billed if investigators are already deployed.

Deliverables

- Written report with timeline and observations
- Photo/video exhibits (time/date stamped when feasible)
- Testimony availability (see rate above)

Compliance Notes

- **Audio:** We do not capture covert audio in areas with an expectation of privacy without consent (Florida is all-party consent).
- **Private Premises:** We follow venue rules and lawful vantage points; we leave upon request to avoid trespass.
- **GPS:** Only with lawful authority or documented owner/authorized-lessee consent.
- **No harassment/stalking:** Operations are limited to legitimate investigative purposes.
